**FUTURE USE OF CITY HALL BUILDING:**

Stacey Brown made the motion to sell the building and property as is, why put more money into it, there will always be work needed to be done. Scianna Leon seconded the motion, all were in favor motion passed.

**FENCING:**

Council wants bids on installing a chain link fence on the back and sides of civic center property, but no one made a motion for me to act on this.

**BUDGET MEETING:**

Allen Anderson made motion to hold the Fiscal Year 10/1/2022 – 9/30/2023 budget meeting before the regular council meeting on September 26, 2022, seconded by Scianna Leon, all in favor motion passed.
